### **What we do:**

Member volunteers conduct all activities of OCAA; we do not have a paid staff. They participate in joint safety and security programs with airport management, assist in many ways with the Town of Ocean City's airport activities, and by providing input to the City Council, aid them in making informed decisions associated with the airport. Why do OCAA members do this? It is because we know the importance of general aviation and the airport to the local communities, and the role it plays in the air transportation system. We would like to share some of this knowledge with you.

The airport provides a valuable service to both community and businesses in many ways. It provides direct access to the Town of Ocean City for those persons and organizations operating general aviation aircraft to fulfill their needs in either seeking relaxation, the conduct of meetings, or the need for convention facilities during their stay. It also serves local residents and businesses that operate aircraft by providing direct access into the air transportation system. This direct routing capability to other smaller communities permits small businesses to operate over a wider marketing area with a minimum of travel time and expense. This "home at night" philosophy results in reducing time away from home and business, and more efficient use of time and money.
